



SOUTH DAKOTA LOTTERY CONTEST GUIDELINES

NASCAR Powerball Playoff May 22, 2023 – July 27, 2023

The South Dakota Lottery's NASCAR Powerball Playoff second chance drawing is available to members of the South Dakota Lottery's Players Club. South Dakotans may enter for a chance to win a NASCAR Powerball Playoff T-shirt, in addition to entry into Powerball's NASCAR Powerball Playoff drawing.

These drawing guidelines have been prepared to ensure the prizes awarded for the promotion are determined as impartially and randomly as possible and that the integrity of the South Dakota Lottery is maintained at all times.

The Executive Director of the South Dakota Lottery reserves the right to change and supersede any outlined procedures to handle unforeseen circumstances.

NASCAR, LLC is not a sponsor of this promotion.

Draw Date:

- July 27, 2023 (5 winners, 5 alternates)

Eligible Tickets:

The following non-winning draw tickets are eligible for entry.

- Powerball
- Mega Millions
- Lotto America
- Lucky for Life
- Dakota Cash

Prizes:

Five winners will receive a NASCAR Powerball Playoff t-shirt and entry into the NASCAR Powerball Playoff national drawing conducted by Powerball.

GENERAL

- A. To be eligible for the drawing, the entrant must be 18 years or older.
- B. The entrant must be a member of the South Dakota Lottery's Players Club.



- C. To become eligible for the drawing, players can enter non-winning, eligible tickets on the South Dakota Lottery's Players Club website or mobile app.
- D. Each non-winning ticket equates to one entry, regardless of number of plays, number of draws, add ons and price points.
- E. Winners of the Lottery's previous NASCAR Powerball Playoff drawings are ineligible for this drawing.
- F. The odds of an entrant being selected as a winner will be determined by the number of entries submitted.
- G. The winners of the drawing will be determined at a publicly held drawing at the Pierre Lottery office in accordance with SDCL Chapter 42-7A, Lottery administrative rules, and these guidelines.
- H. Winners will have 5 days from the date they are notified of their win to submit their confirmation information to receive their prize; should that deadline not be met, the prize will revert to the next alternate.
- I. By accepting their prizes, winners agree to allowing their names and town being published to the Players Club website as well as the South Dakota Lottery social media pages. By accepting their prize winners also agree to being interviewed about their win.
- J. In the event that the South Dakota Lottery is unable to conduct the drawing, due to technological issues or other like circumstances, the Multi-State Lottery Association (MUSL) has been authorized to perform the drawing in a back-up capacity, utilizing the procedures and processes contained in these guidelines.
- K. If any technical issues affect the results of the draw, the Lottery reserves the right to re-conduct the draw.

METHOD OF PROCESSING ENTRIES



- A. All entries must be entered either on the Lottery’s Players Club website or South Dakota Lottery mobile app
- B. Entries must be submitted by 11:59 p.m. central time on July 26, 2023.
- C. Data collected in the course of the promotion is stored on secure servers within a guarded limited access hosting facility and access to data is protected by a variety of security products. The Director of Security for the South Dakota Lottery has been made aware of these security procedures and has deemed them acceptable for the purposes of this drawing.
- D. Internet entries are processed 24 hours a day, seven days a week, from the date and time the promotion begins until the final deadline of the final drawing for which entries are eligible to be submitted. Each entry record contains a date stamp to indicate when it was submitted by the entrant.
- E. Each entry will be validated by Lottery Security, if selected.
- F. All entries are retained in the entry database for the duration of the promotion, regardless of whether or not they are selected in the drawing, to ensure that any entry cannot be submitted more than one time during the course of the promotion.

IV. Trip Prize Description

The Trip Prize consists of a four-day, three-night VIP trip for the winner (“Winner”) and one (1) guest to Phoenix, AZ (“PHX”), from approximately Friday, November 3, 2023 to Monday, November 6, 2023, to participate in a drawing for a prize in the amount of One Million Dollars (\$1,000,000) (“\$1 Million Prize”) to be conducted Sunday, November 5, 2023, during the live television broadcast of the *NASCAR Cup Series Championship™ Race* on NBC (“Program”) from Phoenix Raceway in Avondale, AZ. The Trip Prize shall include the following elements:

- Round-trip, coach-class airline transportation for two (2) people from the major airport nearest Winner’s city to PHX (if within 250 miles of PHX, rail or ground transportation to be substituted);
- Three (3) nights hotel accommodations (selected by Prize Provider in its sole discretion) in PHX (double occupancy, room and tax only);
- Two (2) Ally Curve Hospitality Club passes (includes food, beverages and FanShield Infield Experience access) at Phoenix Raceway for admission to:
 - NASCAR Xfinity Series Championship™ Race at 4:00pm on Saturday, November 4, 2023



- NASCAR Cup Series Championship Race™ at 1:00pm on Sunday, November 5, 2023
- Two (2) passes for VIP Experiences at Phoenix Raceway during NASCAR Championship Weekend™ for Saturday, November 4 and Sunday, November 5, 2023 including:
 - NASCAR Cup Series™ VIP access
 - NASCAR team hauler tour
 - MRN Radio booth tour
 - Pace car rides
 - Pre-Race attendance
 - Victory Lane access
- Two (2) Official NASCAR Championship Weekend™ Event Programs;
- Two (2) Racing Electronics Scanner Rentals for use while at Phoenix Raceway;
- Two (2) Souvenir Gift Bags, each with a retail value of at least two hundred fifty dollars (\$250);
- Two (2) tickets to a Welcome Dinner in Downtown Phoenix on Friday, November 3, 2023;
- All meals while in PHX, including the Welcome Dinner on Friday, November 3, 2023; and
- Ground transportation to and from airports, hotel, and activities in PHX.

Winner is not required to travel to PHX to participate in the drawing for, and remain eligible to win, the \$1 Million Prize. Winner may appoint a proxy to take the trip instead, subject to the Trip Prize Terms and Conditions, and will still remain eligible to win the \$1 Million Prize.

- Winner (or their proxy) may also have the opportunity to participate in the recording and production of the Program and/or appear in the broadcast of the Program, provided that Winner completes and signs all required releases and forms and consents to a background check. If Winner appoints a proxy, the proxy must complete and sign all required releases and clear the background check in order to take the trip. In the event that Winner's designated proxy does not clear the background check, Prize Provider reserves the right, in its sole discretion, either to (i) allow Winner to appoint another proxy to take the trip (subject to background clearance and Prize Provider deadlines); or (ii) allow proxy to travel and to appoint a second proxy (selected by Prize Provider) to participate in the Program.
- For the avoidance of doubt, Winner's eligibility to participate in the trip and/or the drawing for the \$1 Million Prize is not affected by Winner's failure to complete and sign all required release and forms and/or to consent to a background check and/or by any information obtained pursuant to a background check, but those failures may affect the nature of his/her appearance and/or degree of participation in the Program. While Winner's eligibility to participate in the drawing for the \$1 Million Prize is an



element of the Trip Prize, the opportunity to participate in the recording and production of the Program and/or appear in the broadcast of the Program is expressly NOT an element of the Trip Prize and is determined by Prize Provider in its sole discretion. Prize Provider reserves the right to appoint a proxy to appear and participate in the Program for Winner for any reason as it may determine in its sole discretion. The appointment of any proxy shall not affect Winner's eligibility for the \$1 Million Prize.
